- Asbestos Licence
- Permit or Notification from Workcover
- Asbestos Training (non-friable/friable)
- Workcover Approved Supervisor
- Asbestos Removal Control Plan (ARCP)
- Asbestos Removal Clearance Inspection
- Asbestos Pollution Liability Insurance
- Class H HEPA filters on your vacuums
- Application of Polyvinyl Acetate (PVA) to completed work
- Council compliance letter on completion
- Disposal dockets for waste traceability

**Carrying out, or directing or allowing workers to carry out, asbestos removal work without a current licence may be subject to a penalty of up to \$100,000.00 in reference to Section 43 of the WHS Act 2011.**
